Privacy Policy

The following sets forth the policies for the collection and use of personally identifiable information ("Information") by (Priority Vision Inc aka Nip Energy Dip) in connection with its operation of its Web site located at www.nipthegrip.com, (the "Site") and other areas around the web as well as offline (the Site and all other operations together are known as the "Business"), and supersedes any previous statement of such policies. Collection of Information.

In connection with the Site, Priority Vision Inc. may collect Information in the following ways:

- Through emails, telephone calls, or faxes sent to www.nipthegrip.com .
- Via communications between a user and Nip Energy Dip

Priority Vision may also connect non-personally identifiable information from users via "cookies" (small text files placed by Priority Vision, Inc on user computers), single-pixel GIF image files (also called "Web beacons"), Web server log analysis and other similar technological means. Such information may be used to track site trends and enhance the user experience, and may be shared with third parties.

To the extent third parties may place advertising or other content on the Site or through a promotion of Priority Vision, Inc., such third parties may utilize cookies or other technological means within the advertising to collect and utilize non-personally identifiable information. Priority Vision, Inc. is not responsible for information collected by third parties, nor for the collection or use of Information by other sites to which the Site or any promotion of Priority Vision Inc. is linked.

Types of Information Collected by Priority Vision, Inc..

The following types of Information about a user are among those that may be collected by Priority Vision, Inc in connection with the Business:

- Name
- Postal address
- E-mail address
- Telephone number
- Cell phone number
- Date of birth
- IP Address
- Referring site
- Friends
- Photos and Videos
- Other technical information collected by the Site's servers.

Children.

Priority Vision, Inc does not knowingly collect or retain information in connection with the Site from children under the age of 13. Priority Vision, Inc. does not ask children under age 13 for personal information.

Use of Information.

Priority Vision, Inc may use Information collected in connection with the Site in the following ways:

- To send users promotions in connection with Priority Vision, Inc.

- To send users promotions on behalf of a third-party. Such promotions will only be sent by Priority Vision, Inc. on behalf of the third-party.
- To provide requested information, products and services to users via the Site or through other online or offline channels.
- To provide newsletters to our users.
- To improve the user experience with the Site.
- In connection with the operation of the Site.
- For users to obtain information and offers for products and services offered by Priority Vision, nc..

In order to do the foregoing, priority Vision Inc may provide the Information to trusted third parties, including but not limited to selected third party vendors as well as third party contractors providing services to Priority Vision, inc to assist with the operation of the Site and other communication services. Priority Vision Inc. will use commercially reasonable efforts to limit use of the Information by such third parties to the specific uses set forth above. Priority Vision, Inc also utilizes electronic and physical security to reduce the risk of improper access to or manipulation of Information during transmission and storage, but cannot guarantee the security or integrity of the Information and shall have no liability for breaches of security or integrity or third-party interception in transit.

We may also share your information with affiliated and non-affiliated third-parties to offer products or services that may be of interest or benefit to our customers

Priority Vision, Inc may also disclose Information when it determines it is necessary to comply with applicable laws or regulations, in connection with a merger, acquisition, asset purchase or sale of or by Priority Vision Inc, or to protect the interests or safety of Priority Vision, Inc, its customers, or other visitors to the Site.
